Dear Concerned Parties,

Attached to this memo is a directive addressing immigration detainers. Also, the numbers and criteria requested regarding those individuals incarcerated at the Lebanon County Correctional Facility between the indicated dates is enclosed as well.

Currently LCCF does not have a written procedural operation concerning the handling of those individuals incarcerated at LCCF with local criminal charges and immigration detainers. There are two LCCF records clerks responsible for contacting ICE officers via e-mail, when information is received concerning newly incarcerated inmates via the intake and commitment process. In addition to this notification procedure, ICE Officers have access to current inmate files and randomly make on-site visits to investigate said files.

Apart from the previously explained, as well as the attached, no other procedural operation exists on the part of the Lebanon County Correctional Facility in reference to those inmates incarcerated with immigration issues.

An immigration detainer alone will not be justification for incarceration at the Lebanon County Correctional Facility. This policy will not be altered in anyway, unless direct authorization has been issued by the Warden or designee.
