Dear Ms. Chin-Arroyo, Ms. Laigle, and Mr. Davidson:

Thank you for writing to Adams County with your request for information pursuant to the Pennsylvania Right-To-Know law. On October 2, 2018, you requested the following:

- A. *Any record, reports, policies, agreements, correspondence, forms, or documents from 2015 to present reflecting:*
1. *Questions asked of individuals entering or in Adams County PA Correctional Complex (ACACC) about their immigration status, national origin, or country of birth.*
 2. *Sharing of information with ICE about individuals in ACACC (e.g., names, date of birth, immigration status, national origin, country of birth).*
 3. *Sharing of access with ICE to incident reports, booking records, or databases with information about individuals in ACACC.*
 4. *Presence of ICE officials in ACACC (including formal or informal agreements to interview individuals in the complex's custody).*
 5. *Number or times ICE officials visit ACACC to talk to individuals in custody at ACACC.*
 6. *Transferring individuals from the custody of ACACC to ICE custody.*

B. Please provide any document that sets forth your county-wide or correctional complex-specific policy, procedure, or mandate regarding ICE detainees.


Your request is partially granted. In response to section A(1) of your request, a sample "Inmate Commitment Summary Report" is attached. From this report you should be able to ascertain the questions that are asked of individuals entering the Adams County Adult Correctional Complex. A "Commitment Statistic Summary" is also enclosed, which reflects the number of inmates who were released to ICE custody since January 1, 2015, in response to section A(5) of your request.

The remainder of your request is denied because no such records exist in the County's possession. Pursuant to Section 705 of the Right to Know Law, "an agency shall not be required to create a record which does not currently exist or to compile, maintain, format, or organize a record in a manner in which the agency does not currently compile, maintain, format, or organize a record." 65 P.S. § 67.705.

You have a right to appeal this partial denial. If you choose to file an appeal, you must do so within fifteen (15) business days of the mailing date of this response, as outlined in 65 P.S. § 67.1101. Please note that a copy of your original Right-to-Know request and this denial letter must be included when filing an appeal. The law also requires that you state the reasons why the record is a public record and address the reasons the Agency denied your request.
