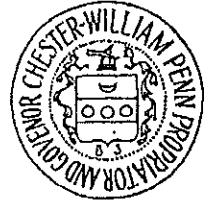

RE: Right to Know Law Request Received October 2, 2018

Dear Ms. Chin-Arroyo, Ms. Laigle & Mr. Davidson:

On October 2, 2018, the Chester County Solicitor's Office received your request for information pursuant to the Pennsylvania Right to Know Law (RTKL), 65 P.S. § 67.101, *et seq.* On October 12, 2018, we notified you that our office required an additional 30 days to respond because the extent and nature of your request precluded a response within five business days under Section 902(a).

Your request delineates six requests for records from the Chester County Prison pertaining to issues regarding inmates, immigration and the Federal Immigration and Customs Enforcement Agency (ICE).

Your request is granted in part and denied in part. Your request is granted to the extent that attached please find the following responsive documents:

1. Medical History Intake Sheet and Commitment Sheet;
2. A Daily Population Report; Initial Commitments;
3. A Daily Population – Summary Report; and
4. Chester County Prison Policies and Procedures: Immigration and Customs Enforcement (ICE) Detainers dated 5/01/14 (Revised 10/03/14).

The remainder of your request is denied for two reasons. First, under the RTKL, an agency is not required to respond to questions, rather it simply provides citizens access to existing public records. Lastly, the records do not exist in a manner which would be responsive to your request. "An agency shall not be required to create a record which does not currently exist or to compile, maintain, format or

organize in a manner in which the agency does not currently compile, maintain, format or organize the record.” 65 P.S. § 67.705.

You have a right to appeal the denials of information contained in this correspondence in writing to the Pennsylvania Office of Open Records, Commonwealth Keystone Building, 400 North Street, 4th Floor, Harrisburg, PA 17120. Please consult the Pennsylvania Open Records Act for your appellate rights at 65 P.S. § 67.101 *et seq.*, more specifically § 1101(a)(1).

Policies and Procedures

Subject: Immigration and Customs Enforcement (ICE) Detainers

Supersedes: All executive orders and related memoranda

Date: 05/01/14 (Revised 10/03/14)

Purpose: To define how Chester County Prison, through its records department, will process a Department of Homeland Security (ICE Detainer) request regarding any Immigration and Customs Enforcement Agency (ICE) detainers issued pursuant to the authority of 8 C.F.R. Section 287.7.

ICE, formerly known as INS, is a department of the Federal Government's Homeland Security Office.

Policy:

Chester County Prison will allow ICE agents access to daily population reports for investigative purposes.

Chester County Prison will accept ICE detainer requests as determined by its agents as valid requests to detain a suspected illegal alien.

Chester County Prison will NOT detain individuals or maintain continuing custody solely on an ICE request. When the detained subject is due for release from Chester County Prison records staff will:

Notify via email to PHILDETAINERPICKUP @ice.dhs.gov upon determination that an inmate is scheduled for release and the ICE detainer is the only thing left holding. The e mail shall contain the name and telephone number of the facility representative coordinating the release.

Include in the body of the e mail the next two lines of this policy:

If ICE agents do not respond to assume custody or contact cannot be made then the subject is to be released and the ICE detainer will be disregarded.

No released subject will be held past his/her release date based upon an ICE request/detainer.
