I am writing in response to your request dated October 2, 2018. Your request is granted insomuch as the Dauphin County Prison has the information on file. The Dauphin County Prison has made a good faith effort under the penalty of perjury, to collect the records and answer the questions raised to the best of its ability. The enclosed and attached information is believed to be responsive.

Regarding your request for "Any record, reports, policies, agreements, correspondence, forms, or documents from 2015 to present reflecting:"

1. Questions asked of individuals entering or in Dauphin County Prison about their immigration status, national origin, or country of birth.

Dauphin County Prison Officers ask place of birth while they are being fingerprinted for processing.

2. Sharing of information with ICE about individuals in Dauphin County Prison (e.g., names, date of birth, immigration status, national origin, country of birth).

Any/all information that is gathered during the intake process is shared with ICE. ICE is able to obtain any/all information entered at the time of processing.

3. Sharing of access with ICE to incident reports, booking records, or databases with information about individuals in Dauphin County Prison.

Dauphin County Prison only contacts ICE when officers receive a hit from fingerprinting the individual. Then the prison will only exchange information about the arrest, so ICE can decide if they are issuing a detainer.

4. Presence of ICE officials in Dauphin County Prison (including formal or informal agreements to interview individuals in the prison's custody).





Local Policy Chapter 6.5

Subject:	ICE/DHS Priority Enforcement Program
Reference:	DHS Form I-247N, DHS Form I-247D

POLICY:

It shall be the policy of Dauphin County Prison to participate in the Department of Homeland Security's (DHS) Priority Enforcement Program (PEP).

PENOLOGICAL INTEREST:

It is in the penological interest of Dauphin County Prison to support the initiatives of U.S. Immigration and Customs Enforcement (ICE), Department of Homeland Security (DHS), via the Priority Enforcement Program (PEP), by notifying and attempting to transfer custody to ICE of qualified individuals who may pose a danger to public safety before those individuals are released into the community.

PROCEDURE:

It shall be the practice of Dauphin County Prison (DCP) to accept either DHS Form I-247N (Request for Voluntary Notification of Release of Suspected Priority Alien) or DHS Form I-247D (Immigration Detainer—Request for Voluntary Action) when provided by or sent to the facility from an ICE agent. This acceptance shall be to only notify and hold an inmate until such time as an ICE Officer can arrive at DCP and accept custody of the released individual.

A copy of the DHS Form shall be scanned, upon receipt, by Records into the electronic Bail Documents folder, titled with the inmate/detainee's DCP# and "ICE" after that number.

It shall further be the practice of DCP to provide notice to ICE before the subject's pending release from DCP. This notice will allow DHS an opportunity to determine whether there is probable cause to conclude that the inmate is a removable alien. This notice shall be provided and documented by Records (or the Shift Commander if the Records Office is unstaffed at the time paperwork for imminent release is received).

Note: ICE shall be given pre-notification notice at least (2) hours prior to the scheduled release of the inmate/detainee. This agreement to notify ICE shall <u>not</u> affect the subject's scheduled date/time of release from the facility. At the two (2) hour mark, the Warden, or Deputy Warden, shall be notified to make the final determination of releasing the inmate. DCP continues its existing practice of not providing 48-hour custody holds under Immigration Detainers.
