Multigenerational Illegality: Transforming Indigenous Peoples to “Illegal” Beings, 16 UC IRVINE LAW REVIEW ____ (forthcoming 2026). This Article incorporates the concept of *multigenerational illegality* into the broader framework of citizenism. *Multigenerational illegality* explains how the system of immigration law and enforcement specifically harms mixed-status Indigenous, Black, Latinx/e, Asian and Pacific Islander families. By blending conceptual analysis with personal narrative, this Article makes three key contributions to the literature. First, it defines *multigenerational illegality*, examining how these families are branded as “illegal” and systematically denied opportunities to obtain immigration status or U.S. citizenship, leading to marginalization across generations. Second, it highlights the complex trauma this system inflicts upon mixed-status and undocumented families over time and space. Third, it introduces the concept of *sacrificios*, the often-invisible acts of love and survival that allow these families to subvert colonial borders and resist systems of subordination.

The Disposable “Essential” Workers of COVID-19, 66:1 BOSTON COLLEGE LAW REVIEW 69 (2025). This Article examines how race, gender, and citizenship affect the employment and life outcomes of essential workers who sustained the economy during the COVID-19 pandemic. Using a health justice approach, it fills a gap in legal scholarship by identifying six employment-related factors that worsen systemic inequalities. By examining COVID-19-related wrongful deaths and discrimination lawsuits involving low-wage workers, the Article assesses the effectiveness of available legal remedies. Despite immense human loss, there are clear lessons for enhancing labor and employment systems to protect, rather than discard, essential workers facing magnified inequalities. Therefore, this Article recommends adopting employment equity principles to address intersectional disparities in employment.

Citizenism: Racialized Discrimination by Design, 104 BOSTON UNIVERSITY LAW REVIEW 831 (2024); *reprinted in* 45 KING HALL’S IMMIGRATION AND NATIONALITY LAW REVIEW (2025). This Article—one of the first in legal discourse—advances the conceptual framework of “citizenism” to explain how citizenship mobilizes and maintains structural racism. Citizenism functions as a legalized system of discrimination that uses citizenship status to perpetuate racialized outcomes for communities of color. Specifically, the system of law and immigration enforcement makes legally permissible presumptions about citizenship based on race, which delimit the fundamental rights of citizens of color. Citizenism provides a new framework for understanding an underlying layer of white supremacy that restricts the civil and political rights of people of color, including citizens of color.

Blood, Soil, and Race: The Perils of Shredding the Fourteenth Amendment, 115 GEORGETOWN LAW JOURNAL ONLINE ____ (forthcoming 2026) (with Hilary Symes). A generational constitutional battle centers on protecting the integrity of the Fourteenth Amendment, which overturned *Dred Scott v. Sandford*. Lawsuits filed across the country challenging the constitutionality of Executive Order 14160 have been

consolidated under *Donald J. Trump v. Barbara*. This Essay demonstrates that this Order is designed to racially restrict access to *jus soli* (birthright) citizenship despite its race-neutral terms. This exclusion will result in multigenerational harms, including facilitating economic exploitation, exacerbating health disparities, and increasing the risk of statelessness.

Misregulating Borders and Gendering Bodies: TransLatinxs Asylum Seekers, in HANDBOOK ON THE POLITICS OF ASYLUM (DeGruyter-Brill ed., *forthcoming* 2027). This chapter examines the various ways gender and economic refugees—TransLatinxs—migrate from Latin America. It also describes how gender and LGBTQIA+ migrants access and navigate gender-based asylum claims. The chapter then proposes that these processes adopt an intersectional framework to effectively address the multiple vulnerabilities undocumented TransLatinxs face.

WORKS IN PROGRESS

The Harms of Racialized Immigration Enforcement. By documenting the racialized design of immigration enforcement and the egregious constitutional and civil rights violations committed by the Department of Homeland Security (DHS) over the past twenty-plus years, this Article examines the legal, policy, and human costs of maintaining this system. Framing this discussion within a historical context of racialized enforcement, it builds on the concept of *multigenerational illegality* to demonstrate how citizenship harms families and communities of color across generations through state-sanctioned violence. This Article also analyzes how increased federal funding for DHS supports an immigration enforcement system that harms both citizens and noncitizens of color and weakens the fabric of our fragile democracy.

Brown Like Us (with Khaled Beydoun). This Article compares the racialization of Arabs/Middle Eastern, Muslims, Indigenous people, and Latines/xs in the United States. By clarifying the definition of brown identity and highlighting the law as the main channel of Brown racial formation, it underscores the disconnect between official race categories and cultural race. This Article also illustrates the Critical Race Theory principle that race is fluid and unstable, framing this analysis within a historical context and Indigenous futurisms to challenge racial projects by empires that seek to erase or subordinate Brown people.

Unearthing Milagros [Miracles]: Rooted Visions of Liberation (with Cinthia A. Ibarra and Bamby Salcedo). The co-authors apply a Participatory Law Scholarship (PLS) approach to rethink border and gender systems. Specifically, this Article explores how citizenship poses challenges for intersectional undocumented communities, drawing on the lived experiences of movement activists who confront legal dysfunction. It enhances PLS by emphasizing the expertise of activists who have been harmed by patriarchy and the system of immigration law and enforcement. Notably, the co-authors ground their contributions on expansive possibilities for justice across space, time, genders, and borders.
