## ADMINISTRATIVE LAW PRACTICUM (PHILADELPHIA BOARD OF ETHICS)

Number of Slots: up to 2

Faculty Supervisor(s): Professor Harwell Wells

Time Commitment: minimum 6.5 hours or 10 hours per week (depending on credits)

Number of Credits: 2 or 3

Required Application Documents: Resume, Cover Letter/Statement of Interest

This practicum is with the Philadelphia Board of Ethics. The Philadelphia Board of Ethics was created in May 2006 by amendments to the City's Home Rule Charter. The Board interprets, administers, and enforces the ethics provisions in the Charter and City Code. These include the City's rules governing conflicts of interest, representation in City transactions, post-employment restrictions, gifts and gratuities, interests in City contracts, political activity, financial disclosure, lobbying, and campaign finance. Via its Enforcement Staff, the Board investigates potential violations of the laws within its jurisdiction and enforces those laws through administrative adjudication or court proceedings. The Board issues formal advisory opinions and promulgates regulations interpreting City ethics laws. The Board's General Counsel Staff also provides informal advice, develops and delivers ethics training, and offers compliance assistance to the regulated community.

In this practicum, the student will work closely with either Enforcement Staff or General Counsel Staff in furtherance of the Board's mission. If assigned to Enforcement Staff, the student will assist staff in ongoing investigations of potential violations of the Public Integrity Laws as well as matters in active enforcement via legal analysis, research, and writing, and will review documents sent in response to subpoenas and formal requests. The student will learn investigatory techniques and methods and will be asked to think creatively to explore leads and develop theories of the case. Depending on timing, availability, and the student's progress throughout the semester, the student may be asked to take the lead in witness interviews and other investigation events. If assigned to General Counsel Staff, the student will assist staff with their regulatory work. The student will be tasked with background research, drafting, and presentation of recommendations for new or amended ethics regulations. The student will also have the opportunity to attend regular General Counsel Staff meetings, which will provide exposure to Staff's work on advice, training, and other projects.

This Practicum is ideal for law students who are committed to, or interested in learning more about, administrative law, regulatory agencies, and municipal government. Students are not expected nor required to have taken administrative law prior to this Practicum. Students will need to commit to a minimum of 6.5 to 10 hours per week to this Practicum depending on the number of credits they prefer. Because this Practicum involves active collaboration with Board Staff, at least a portion of the hours to fulfill this Practicum (if not more) will need to be completed in-person at Board of Ethics offices, as arranged between the student and attorney supervisor. ## **CIVIL LITIGATION PRACTICUM (UNITED STATES ATTORNEY’S OFFICE – CIVIL DIVISION)**

This practicum with the Civil Division of the United States Attorney’s Office in Philadelphia supplements traditional classroom study by offering students the opportunity to hone their legal skills by working with Assistant United States Attorneys (AUSAs) toward the resolution of cases in litigation or at the pre-complaint stage. Students will have the opportunity to deepen their substantive knowledge, sharpen essential lawyering skills, and appreciate professional values of the legal profession. Under the supervision of one or more AUSAs in the civil division of the United States Attorney’s Office in Philadelphia, students will engage in and observe all phases of work of the civil side of the United States Attorney's Office—to include both affirmative and defensive litigation—in subject areas including, but not limited to: torts, employment discrimination, civil rights, disability rights, environmental law, and healthcare fraud. Students will assist civil division AUSAs with a variety of casework, the nature of which depends upon the needs of each case. Assignments may include legal research, analysis, and writing; attending meetings and court hearings; assisting with witness interviews and taking/defending depositions; drafting and responding to discovery; and participating in all aspects of arbitrations and trials (including witness examination). Externs will have regular opportunities for feedback.

Students will need to commit to a minimum of 10 hours per week to this Practicum. To participate in this Practicum, students must also be eligible for court certification. A security clearance must be obtained prior to the start of the semester's work, which requires selected students to provide their Social Security Card, Passport, and/or Birth Certificate.

The District Attorney's Office is responsible for prosecution of over 50,000 criminal cases yearly. In this Practicum, students will have the opportunity to work in one of the following units: Appeals, Federal Litigation, or PCRA.

This practicum is with the Conviction Integrity Unit (CIU) of the District Attorney’s Office (DAO). Attorneys in the CIU review and investigate claims of actual innocence and wrongful conviction. The CIU also develops and implements office-wide policies to prevent future wrongful convictions and ensure a higher level of integrity and fairness in the criminal justice system. CIU attorneys, alongside paralegals, create detailed reviews of an applicant’s case history, interview witnesses, and may ultimately write briefs to be filed pursuant to post-conviction proceedings.

This practicum is designed to immerse students in the CIU’s work and expose them to each critical stage of CIU case review. In this hands-on program, the students will receive their own case assignments and, in the course of their investigations, will review the Commonwealth’s trial files and police files, gather documentation and archival evidence, collaborate with investigators and attorneys, and assist in preparation for witness interviews. Apart from case assignments, students may also assist the CIU with research and policy development.

This program is uniquely designed to help develop investigative and case assessment skills and understanding of the workings of the criminal justice legal system as a whole.

This practicum with the Criminal Division of the United States Attorney’s Office for the Eastern District of Pennsylvania supplements traditional classroom study by offering students the opportunity to gain practical legal experience through hands-on work with Assistant United States Attorneys

(AUSAs) involved in the investigation and prosecution of federal criminal cases. Students will deepen their understanding of criminal law, develop critical lawyering skills, and appreciate the ethical responsibilities of the legal profession. Under the supervision of one or more AUSAs, students will participate in and observe various phases of the federal criminal process, including investigations, pre-trial hearings, trials, and sentencing proceedings.

Students will assist AUSAs with a variety of tasks, which may include legal research and writing, drafting motions and briefs, assisting with evidence collection, interviewing witnesses, preparing exhibits for trial, and attending court proceedings. Depending on the needs of each case, students may also be involved in drafting and reviewing plea agreements, assisting with discovery, and observing or participating in courtroom advocacy.

Students will need to commit a minimum of 10 hours per week to this Practicum. A security clearance must be obtained prior to the start of the semester's work, which requires selected students to provide their Social Security Card, Passport, and/or Birth Certificate. Clean Air Council is Pennsylvania's oldest environmental and health non-profit organization and has been working to protect everyone's right to a clean and healthy environment for over 50 years. The Council pursues cutting-edge litigation, participates in federal and state rulemakings, watchdogs environmental permitting, and champions impactful policy reforms; all in close collaboration with impacted communities.

The Council was founded in 1967 by a group of forward-looking community leaders, policy makers, and progressive business leaders. Headquartered in Philadelphia, the Council made a name for itself by the mid-1970s as the result of two major achievements: establishing and distributing a daily regional air quality index report (still in use today); and forcing Pennsylvania to implement its vehicle emissions testing program. The Council is continuing this tradition of tackling big challenges through programs to address the public health and environmental threats caused by shale gas extraction and distribution, climate change, developments in our energy markets and infrastructure, and major stationary sources of air pollution.

The Council maintains an active litigation docket addressing a broad range of environmental health issues in Pennsylvania and beyond. The Council regularly brings cases in both state and federal courts and before agency tribunals, such as Pennsylvania's Environmental Hearing Board and Public Utility Commission. We litigate a wide variety of issues within the realm of air quality regulation, water law, and energy law. The Council also engages in a significant amount of policy work, leading the charge on a variety of issues in Pennsylvania such as Pennsylvania's implementation of carbon cap and trade and regulation of methane emissions.

Students participating in the practicum will make substantive contributions to the Council's legal program and, with full support from senior attorneys, will take on staff attorney-level tasks. This

practicum requires that students commit to 10 hours per week. Students have an opportunity to assume a great deal of responsibility, while receiving mentoring from a close-knit group of environmental attorneys.

This practicum is designed to expose students to the broad intersection of litigation, transactional work, policy, advocacy and work with grass-roots organizations. It provides a specialized and unique course of study focused on the local region's natural heritage, practical legal skills, and special issues and pitfalls in environmental law. In conjunction with this placement, students will work closely with the Delaware Riverkeeper as well as the senior and staff attorneys of the Delaware Riverkeeper Network to provide legal support to environmental professionals and citizens to help effectively protect our environment and communities through compliance with the federal, state, and local environmental laws and regulations. Under the supervision and guidance of the senior and staff attorneys, students will be expected to act as junior staff attorneys – perform legal research; draft strategy memoranda, pleadings, briefs and other legal documents for timely filing with courts and other government agencies; and write and present comments and testimony before bodies considering proposals that will affect the environment.

Please note that the experiential hours of this practicum may be completed remotely or in-person (to be determined between you and the practicum). Any in-person experiential hours will be held at the Delaware Riverkeeper Network, which is located at 925 Canal Street in Bristol, Pennsylvania, directly across from the Bristol train station (SEPTA Trenton Line) and has ample parking.

This practicum is ideal for students who are committed to, or interested in learning more about, a career in environmental law, or students who want to gain writing experience. Students must complete a minimum of 10 hours each week of the semester of experiential work, classroom learning, or out of class assignments. Preference will be given to students who have taken, or will take concurrently, Environmental Law and Natural Resources. **FAMILY LAW PRACTICUM (CHILD ADVOCACY UNIT – DEFENDER ASSOCIATION OF PHILADELPHIA)**

This practicum is with the Defender Association of Philadelphia. The Defender Association of Philadelphia is a nonprofit law firm created in 1934 by a group of lawyers dedicated to the belief that everyone, regardless of income, deserves the highest quality legal representation. Firmly rooted in Philadelphia for over 80 years, the Defender Association stands as the city's vanguard for indigent defense.

The Child Advocacy Unit (CAU) is a specialty unit within the Defender Association that ensures quality representation inside and outside of the courtroom for children involved in dependency and adoption cases. The CAU was created in 1974 and contracts with the City of Philadelphia to represent children, ranging from birth to twenty-one years old, who have open dependent petitions in Family Court; are victims of neglect, physical abuse, sexual abuse, or abandonment; are truant or incorrigible; are facing mental health challenges; need additional supports as they transition into adult living or desire to re-enter the dependent system through a Resumption of Jurisdiction Motion. The CAU utilizes a multi-disciplinary approach to child advocacy by teaming attorneys and social workers to represent our young clients. They represent most of the dependent children in Philadelphia, and presently have 38 staff attorneys, 34 social workers/social service advocates and 5 peer advocates.

In this practicum, students are expected to participate in all aspects of representing our clients, who range in age from birth to 21 years of age. The practicum curriculum will focus on how to collaboratively work a case using a strengths-based lens of looking at the family and how to navigate the system for the maximum benefit to the client; our multi-disciplinary team approach (social worker/attorney); courtroom experience (permanency and dispositional hearings); developing interviewing, counseling and investigatory skills; research into community programs and services for our clients and their families; collaboration with outside agencies to meet the needs and welfare of our clients; ethical considerations inherent in our dual role of counsel and guardian ad litem; developing the appropriate tools to successfully communicate with clients and conduct legal research, analysis and writing as needed.

This practicum is ideal for law students who are committed to, or interested in learning more about, a career advocating on behalf of children in the dependency arena and the child welfare system, or a career in public interest law. Students will need to commit to a minimum of 10 hours per week to this Practicum. Students in the practicum will work under the supervision of experienced immigration attorneys at Aldea—The People’s Justice Center and will be primarily responsible for assisting them in matters before the Board of Immigration Appeals (BIA), the federal district courts, and the Third Circuit Court of Appeals. Students will conduct legal research and write briefs on appeals from adverse rulings in immigration proceedings, including denials of asylum, withholding, and cancellation of removal. Aldea—The People’s Justice Center provides high quality, pro bono or discounted representation to immigrants and noncitizens in the Philadelphia region as well as in other states.

This is an excellent opportunity for students interested in immigration law as participants will receive supervision, training, and experience in how to successfully represent clients before the BIA and federal courts. Students will need to commit to 10-12 hours per week for this practicum and the work will be performed remotely. Preference will be given to students with a background or documented interest in immigration law as well as to those students who have strong research and writing abilities.
