## ITP (INTEGRATED TRANSACTIONAL PROGRAM) - FALL 2024 & SPRING 2025 SCHEDULE

To register for ITP, simply enter the CRN 22591. You will later be administratively registered in Trusts and Estates (T&E) and Professional Responsibility (PR) and assigned to one of the Transactional Practice sections. NOTE: If you register in ITP, do not register for another section of T&E or PR. Successful completion of ITP satisfies the PR requirement and students may elect to have ITP fulfill either 4 credits of the Experiential coursework requirement or the Serial Writing requirement (but not both). Accommodations are made for evening students who cannot arrive at the Law School before 6 pm.
